- LIABILITY STATEMENT:** Each skipper must acknowledge that she accepts personal responsibility of up to \$500.00 in the event the boat she is skippering is damaged.
- NUMBER OF ENTRIES:** Each club may request 2 entries per division, subject to availability of boats, which will be reserved on a first-come basis.
- RULES:** The race will be governed by the rules in *The Racing Rules of Sailing.*

TEAMS: Club teams will consist of a skipper and 3 crew, all of whom must be members of **FWSA**. The skipper must also be an individual member of **US Sailing**. Teams may consist of women from one or more clubs.

AWARDS LUNCHEON Following the regatta a buffet luncheon, organized by the SARASOTA LUFFING LASSIES, and the presentation of awards will be held at the Sailing Center. Awards will be presented to the competitors finishing first, second and third in the Spinnaker class and first, second and third in the Non-Spinnaker class.
